

Terms and Conditions

Name the Crane competition – Eurobodalla Regional Hospital project

- By entering the *Name the Crane* Competition (the competition), an entrant is indicating his/her agreement to be bound by these terms and conditions.
- The purpose of the competition is to name the tower crane on the Eurobodalla Regional Hospital site.
- Entries are open to primary school students who live or go to school in the Eurobodalla, or whose parents/guardians work at Batemans Bay or Moruya Hospital.
- The competition is being run by Health Infrastructure and Southern NSW Local Health District.
- The competition closes at **6pm on 25 March 2025**. After this date no further entries to the competition will be permitted.
- The winner and runners up of the competition will be notified by telephone or email within 28 days of the closing date.
- No responsibility can be accepted for entries not received for any reason.

- To enter the competition, entrants must choose a name for the crane on the worksite, tell us why they've chosen the name, colour in the form, complete their details including name, age, suburb and school, and have the entry form completed/signed by a parent/guardian.
- Entrants must email their completed entry form to: HI-EurobodallaHospital@health.nsw.gov.au
- Each entrant may only enter the competition once. Multiple entries from the same person will be disqualified.
- Prizes have been generously supplied by the project builder Multiplex and include:
 - An iPad for the winner and the winning name to be displayed on the crane.
 - Runners up will receive Lego packs.
- Judging will be conducted by a panel including a representative from the Southern NSW Local Health District project team/employee, a Health Infrastructure representative, RP Infrastructure representative and a Multiplex representative.
- Entries will be judged on the creativity of the crane's name, given the child's age. The judging panel's decision is final and no correspondence will be entered into.
- Entries which are incomplete, incorrect, offensive, non-serious or incomprehensible will be ruled ineligible.
- Any personal data relating to winners or any other entrants will be used solely in accordance with current Privacy and Personal Information Protection Act 1998 and will not be disclosed to a third party without the entrant's prior consent.
- There is no entry fee and no purchase necessary to enter this competition.
- Prizes are not transferable or exchangeable and cannot be taken as cash.

- Collection of prizes will be made available at a naming the crane ceremony on site or by arrangement with the Eurobodalla Regional Hospital project team contact 1300 391 949 or HI-EurobodallaHospital@health.nsw.gov.au
- Any transport costs or ancillary costs to attend an official crane naming ceremony at the Eurobodalla Regional Hospital site are at winner's expense
- Winners consent to their name and photo being used in Eurobodalla Regional Hospital promotional material.
- Winners consent to being interviewed and photographed by local media at the official crane naming ceremony.
